



INSTRUCTIONS TO THE AUTHORS

1.OBJECTIVES

The General Journal of Roman Law (Revista General de Derecho romano -RGDR) arises within the framework of the "Revistas generales de Derecho" framed in editorial iustel.com. With great commitment to personal and scientific collaboration, a sense of academic responsibility, and firm determination, we put into circulation a worthy and prestigious Journal, which began its journey in January 2004, within the framework of the Legal Portal www.iustel.com. It constitutes the first scientific journal of Roman Law that sees the light in our country. It is aimed especially at Roman law scholars, positive law jurists and legal practitioners, historians, philologists and philosophers in order to disseminate original and unpublished papers on history, dogmatic and legislative research in the fields of Roman law and legal tradition at the national and international scope, in order to serve as a link in the construction of current law. For this reason, the RGDR has welcomed from its birth, as a priority, contributions that in terms of institutions, sources or methodology, are made within the classical framework of scientific and university autonomy of Romanistic studies.

2.INSTRUCTIONS

Papers must be submitted in Microsoft Word. Contributions may be sent by mail to the Director of the Journal, prof. Antonio Fernández de Buján y Fernández, antonio.bujan@uam.es, or to following address at <http://www.iustel.com:revistas@iustel.com>.

The files must be named with the surnames of the author of the papers or with words that refer to the title or content of the file when it is not a doctrinal paper, followed by a dot and abbreviation of the corresponding section of the Journal. The abbreviations for each section are as follows:

- a) est. : Studies
- b) var.not.: Various: Notes
- c) var.recen.: Various. Reviews
- d) var.necr.: Various. Obituary
- e) rev.: Magazines and summaries
- f) bib.: Bibliography, Collections
- g) acad.: Academic information

3. PUBLICATION REQUIREMENTS

In all doctrinal papers, whatever the language in which they are written, must be adapted to those adapted to publication rules and in a particular way:

- Title in Spanish and English.
- Summary and keywords in Spanish and English.
- The works may be written in Spanish, English, French, Italian, German or Portuguese.
- The format that is established is Arial 10 with single spacing.
- The name and surnames of the author will be in capital letters and their position in small letters. Both in round font, without bold and centered. Likewise, your contact e-mail must be provided.
- Each of the sections into which the work is divided will be centered. The first epigraphs will be presented in capital letters, in Roman numerals, centered and in bold; the first sub-headings will be presented in lowercase letters, in Arabic numerals, centered and in bold; From here on, the following possible subheadings will be in lowercase letters, in Arabic numerals, centered and without bold.
- The citations of the works must be in footnotes according to the citation standards in Spanish legal publications (ISO 690, ISO 690-2 and UNE 50-104-94)
- Source of funding or grant for the research with the project identification data indicated in the footnote, asterisk or, where appropriate, in the acknowledgments.
- The ORCID number (persistent digital identifier) of the author or authors must be included, besides indicating the number of who signs in at first and successively in the case of multiple authors.
- In any case, in order to comply with good editorial practices on gender equality, scientific articles must use inclusive language.
- The source data of the research must take into account gender, in order to allow the identification of possible differences.

The extension of the works will be adapted to the following parameters:

- - Studies: 15 - 30 pages
- - Comments: 10-20 pages
- - Notes: 2-5 pages
- - Book reviews and reviews: 5-10 pages
- - Book notes: 2 pages.

The following dates are established as non-extendable dates for sending contributions.



DEADLINES

Until november 15	for publication of the december issue
Until may 15	for the publication of the june issue

In order to improve the impact of the journal, the number of articles published in each issue will be reduced to around fifteen, which will be selected for publication from among the originals submitted.

4. ISSUES RELATING TO THE PUBLICATION OF THE PAPERS

In relation to copyright, authors can use their rights to publish their works in any other publication, always on paper (and not in electronic format), with the sole requirement of acknowledging the previous appearance in the corresponding Revista General, in this case Revista General de Derecho romano, including the name and domain of the Journal the site <http://www.iustel.com>.

The Editorial board of each of the “Revista General” will demand that papers be original, although there will always be exceptions if, due to the importance or topicality of the subject, teams consider it of interest to publish a work in the Revista General once it has been disseminated by another periodical of paper.

PORTALDERECHO S.A.(Inc.) is authorized to the publication in paper format of the manuscripts sent by the authors.

5. EVALUATION

No sooner the text is received, the RGDR Director will send the original to two members of the Board of Directors or Editorial Board, depending on the subject on which the referred work is to be viewed, so that they can issue a first evaluation within a maximum period of two weeks.

After this first screening, the paper is sent to two external evaluators so that, anonymously and following “double-blind peer review system”, they issue an assessment on it in accordance with the form established for this purpose and that is sent to them along with the paper to evaluate.

If one of the reports is favorable and the other is unfavorable, Director will send the work to a third evaluator. If this third evaluation is positive, the manuscript will finally be published in journal.

The Editorial Councils of the Revistas Generales of <http://www.iustel.com> constitute independent evaluation teams.
